I am trained in and have experience using Parent-Child Interaction Therapy (PCIT), a highly effective modality for treating ADHD and other disruptive behavior disorders in children. Adolescent populations have been a specialty client group of mine through the years of my career in a variety of settings and continues in my private practice. I have presented on the subject of mother-daughter dyad relationships in adolescence at the San Diego Psychological Association Fall Conference 2010, and presented at other professional workshops throughout the years on similar subjects within my areas of expertise.
